## MEMBERSHIP QUALIFICATIONS

**INDIVIDUAL:** Individual members are persons who possess serious interest in outdoor communications, which may include being published and paid. The outdoor communication may take the form of, but is not necessarily limited to: writing, photography, painting, illustrating, editing, or publishing. Individual members shall have full voting rights in all the business of the corporation.

**SUPPORTING:** Shall be persons or organizations who ascribe to the tenets of the corporation and who desire to assist in the promotion of the purposes of the corporation. Supporting members may attend and participate in all meetings and functions of the corporation, but shall have no voting rights. One supporting member may be selected to the board of directors for a two year term, and has full board voting rights.

**STUDENT:** Shall be full-time students regardless of age.

**LIFE:** Awarded to individual members at the discretion of the Board of Directors. Exempt from paying annual dues, but retain all privileges.

**HONORARY:** Awarded at the discretion of the Board of Directors. Shall be limited to one year, unless otherwise approved by the board. Exempt from paying annual dues, but retain all privileges.
